1 YEAR 12 RESULTS ONLINE

All 2016 WACE students with at least one scaled score will be able to access their TISC Universities Admission Advice Letter information (including scaled scores and ATAR) via the TISC website at www.tisc.edu.au.

Results will be available from Wednesday 28 December 2016.

2 UNIVERSITY APPLICATIONS

Applications are still open at www.tisc.edu.au. A late processing fee of \$150 now applies.

This year 12,008 WACE students applied by 5 October (includes all on-time 30 September closing date applicants) compared with 12,143 at the same time last year.

3 CHANGING PREFERENCES

Once they have applied, students may change preferences as many times as they wish, subject to closing dates, without incurring any extra charge. However, it is advisable for them to wait until their university admission information is available from Wednesday 28 December 2016 before making changes.
