FOREWORD

As Chairs of the TISC Board and Members Advisory Committee it is a pleasure to present the 1 July 2023-31 December 2024 Annual Report of the Tertiary Institutions Service Centre (TISC).

This report contains information about the various functions and operations of TISC together with statistical information on the 2023-24 and 2024-25 applications cycle. These two admissions cycles have been included in this year's annual report as the report covers and 18 month transition period to a calendar year financial year ending 31 December from 2025. Detailed statistical tables relating to 2023 and 2024 WA Year 12 results, and 2023-24, as well as 2024-25 application, offer, and enrolment information, are available at www.tisc.edu.au.

The 2023-24 admissions saw Curtin University (Curtin), Edith Cowan University (ECU), Murdoch University (Murdoch), and the University of Western Australia (UWA) require all Year 12 applicants to apply for their institutions through TISC. The University of Notre Dame Australia (UNDA) allowed Year 12 applicants to apply through TISC and/or to continue to apply directly to UNDA. Mature age applicants could apply through TISC and/or directly to their institution of choice.

This Annual Report includes the audited financial statements of TISC over the forementioned 18 month transition reporting period. This is because the Board of TISC has adjusted the standard accounting period of TISC from 1 July to 30 June, to 1 January to 31 December commencing 1 January 2025. Associated endorsement from the Australian Charities and Not-for-profit Commission (ACNC) and the Australia Securities and Investments Commission (ASIC) have been received. As such, the period from 1 July 2023 - 31 December 2024 is a special accounting period.

During the 2023-24 admissions cycle, TISC processed a total of 13,987 undergraduate university applications, resulting in 12,207 offers being made for Semester One 2024 entry. 11,009 of those offers were to school leavers. During 2023-24, 1,070 candidates completed the Special Tertiary Admissions Test, and 73 students completed the 2023 WA Universities' Foundation Program.

During the 2024-25 admissions cycle, TISC processed a total of 14,883 undergraduate university applications, resulting in 13,276 offers being made for Semester One 2025 entry. 12,049 of those offers were to school leavers. During 2024-25, 1,070 candidates completed the Special Tertiary Admissions Test, and 76 students completed the 2024 WA Universities' Foundation Program.

TISC remains committed to its schools outreach and engagement activities where students are equipped with all the information required to navigate their journey to their university of choice. In addition to metropolitan schools TISC made visits to Kalgoorlie, the Great Southern, Bunbury and the South-West, as well as Geraldton. In both the 2023-24 and 2024-25 admissions cycles TISC made over 100 school visits where we spoke to an estimated combined audience of over 7,000 students and parents per annum. We also provided a number of online webinars for students and parents to access from around Western Australia and beyond.

During 2023-24 two major changes to TISC's Constitution were approved. The first change was to provide for the appointment of Independent Directors to the TISC Board. This change was brought about as the TISC Board wished to expand the range of expertise on the Board, particularly expertise and experience in the senior secondary school sector. As a result, the Board welcomed Ms Milanna Heberle as an independent Director commencing in November 2024. The second change was to TISC's standard accounting period as referenced above.

In 2023-24 The TISC Board also made a decision to increase the equity of Australian Tertiary Admission Rank (ATAR) calculations. This was done by removing bonus points for Mathematics Methods, Mathematics Specialist and a student's highest Language Other Than English (LOTE) from calculation of the Tertiary Entrance Aggregate (TEA) and the ATAR. Following community feedback on this decision, the implementation date for this initiative was subsequently postponed to Year 12s in 2028. Over 2024 and 2025 TISC has committed to consult widely with key school and university sector stakeholders on the 2028 tertiary entrance aggregate and associated ATAR calculations before making associated recommendations to the TISC Board.

Once again, we acknowledge the future-focussed, innovative, and inclusive TISC team for everything they do to support TISC's member universities and associate member institutes of higher education. The TISC team has demonstrated a long track record of using technology and their understanding of the admissions journey to deliver timely, low-cost, student-centric services to all those aspiring to study at WA's world class higher education institutions.

We also wish to thank TISC's Board of Directors, the Members Advisory Committee, and the various committees of TISC for their continued commitment, cooperation, and support. We also wish to thank those members of the wider Western Australian community who gave their considerable expertise, wisdom, and time to TISC over the June 2023-December 2024 period.

A new constitution was subsequently drawn up in June 1984 to establish the Tertiary Institutions Service Centre (Incorporated) (TISC Inc) under the Associations Incorporations Act 1895-1982. The constitution was revised in April 1995, and again in June 2001.

In 2017, as a result of a strategic review conducted the previous year, a new constitution was adopted, and TISC registered as a not-for-profit company, limited by guarantee, on 1 February 2018. TISC Ltd is also registered as a charity with the Australian Charities and Not-for-profits Commission.

Specific Purpose Committees

Scaling Policy Committee

The Joint School Curriculum and Standards Authority (SCSA)/TISC Scaling Policy Committee reviews and determines scaling policy and procedures for WACE courses. The Committee meets when major scaling policy decisions are made. No meetings of the Scaling Policy Committee were held in this reporting period.

Professor Nicola Armstrong, Director of Graduate Research in Mathematics and Statistics at Curtin University continued in her role as Chair of the Scaling Policy Committee and represented TISC at the national ATAR methodology workshop convened by the Australasian Conference of Tertiary Admissions Centres (ACTAC).

General Developments

In 2023-24 TISC further progressed its governance initiatives, foreshadowed a significant future change to the calculation of the Australian Tertiary Admission Rank in Western Australia, consulted with a range of stakeholders on that change, introduced predicted ATAR and other functionality to support universities as part of the early offer process, commenced assessing Educational Access Scheme applications on behalf of all WA universities, responded to the Universities Accord and Pathways to Post-School Success reports, commenced a new approach to member institutions' financial contributions to TISC, and prepared for the new September-onwards early offer timeframes instigated by the Federal Minister for Education.

As part of TISC's ongoing governance focus, its Board undertook a regular review during 2023-24. This review included a Directors self-evaluation survey, review of the Board skills matrix, and benchmarking with similar organisation Board structures. The key outcome of this review being the Board's view that TISC would benefit from having access to expertise and experience from the senior secondary education sector. As a result, a General Meeting of TISC held on 21 June 2024 approved an amendment to the TISC Constitution facilitating appointment of independent director(s) to the TISC Board. Ms Milanna Heberle, Executive Director, System and Response and Transformation at the WA Department of Education joined the TISC Board in November 2024.

Associated with TISC's governance and quality activities over 2023-24 the Board approved a TISC People and Culture Policy, and an updated Risk Framework incorporating a revised Risk Appetite Statement and a Risk Assessment Matrix. The Board also approved an update to the TISC and Member Universities Principles and Protocols document which serves to facilitate the operation and consistency of the TISC admissions system.

In 2023-24 the TISC Board also made a decision to increase the equity of Australian Tertiary Admission Rank (ATAR) calculations. This was done by removing bonus points for Mathematics Methods, Mathematics Specialist and a student's highest Language Other Than English (LOTE) from calculation of the Tertiary Entrance Aggregate (TEA) and the ATAR. As noted in the Foreword, following community feedback on this decision, the implementation date for this initiative was postponed to Year 12s in 2028. TISC will establish an Incentives Taskforce to recommend post-ATAR calculation incentives to the TISC Board in 2025. This incentives framework will be developed in time for Year 10s to know the incentives on offer for 2028 Year 12 courses as they commence Year 10 in 2026.

One of the objects in TISC's constitution is to enhance interest and participation in tertiary education in Western Australia. This has become an increasingly important part of TISC's activities given the fall in WA ATAR participation rates to 27.4% in 2024, the lowest State figure in the country and some 25% lower than Eastern seaboard states.

The importance of increasing ATAR course participation has been reinforced by the Australian Universities Accord Report (the Accord) which recommended at least 55% of 25-34 year olds attain a bachelor degree qualification by 2025, compared to 45% in 2023 (noting many will also have a VET qualification). Reaching this target would mean doubling the numbers of students in Commonwealth supported places by 860,000 to 1.8m nationally by 2050 across all age groups.

Completing ATAR courses is still the best predictor of success in higher education. TISC continues to engage university leadership teams as well as the Minister for Education, School Curriculum and Standards Authority, Department of Education, Catholic Education WA, the Association of

Independent Schools WA, school systems, principals and deputy principals on initiatives to lift ATAR course participation in Western Australia. We look forward to the outcomes of the Pathways to Post School Success recommendations and to supporting SCSA's WACE Refresh initiatives.

The TISC Information Technology team continued to punch above its weight and delivered significant system and workflow upgrades during the year. These achievements are detailed in the Information Technology Developments section of this report.

During 2023-24 TISC continued to work closely with sister organisations through the Australasian Conference of Tertiary Admissions Centres (ACTAC). ACTAC facilitates communication and cooperation between tertiary admissions centres in Australia and New Zealand. This cooperation is facilitated by sub-groups for Operations, Marketing, and Technical activities.

Applications and Offers

2023-24

The 2023-24 applications cycle saw 13,988 (14,387 last year) applications made through TISC. This reflects a 2.8% reduction in applications compared to the previous year due mostly to a decrease in mature age and interstate Year 12 students.

The issuing of early offers to applicants either directly by universities, or via TISC continued in 2023-24. However, many of these offers were made outside the TISC system, so limited information is available on early offers for this year. It is worth noting that for the 2024-25 admissions cycle, Year 12s have been advised to apply through TISC by all primary members, and that they may apply through TISC, or directly, for the University of Notre Dame Australia.

The universities made offers to 12,217 (11,939 in 2022-23) TISC applicants in total, with 79% (77%) of all applicants who were made an offer receiving their first preference. Offers were made to 11,016 (9,150) WA Year 12 students, or 95% (94%) of all WA Year 12 applicants. The total number of offers made increased by 2.3%, compared with a total decrease of 2.8% in application numbers. It is noted the percentage of offers made to WA Year 12 applicants increased by 1% to 95% in 2023-24. This is the highest percentage recorded in the past 16 years.

The Educational Access Scheme continued to facilitate applicants to have disadvantage considered as part of their application for university study. Some 902 (751) students requested consideration through this scheme and 628 (528) offers were made to students who applied for the EAS, although these applicants may have received an offer irrespective of their EAS application.

The Special Tertiary Admissions Test (STAT) accommodated 1,070 candidates in the 2023 STAT year (1,192 in 2022). In 2023, 87.8% (86.3%) of candidates who sat both components of the STAT met the minimum entry requirements for Curtin, ECU, Murdoch, and UNDA. (Note: For 2024 admission, UWA did not set minimum STAT scores but required the scores for STAT WE and at least one component of STAT MC to equate to a notional ATAR equal to or greater than the minimum required for the course.)

Enrolments in the WA Universities' Foundation Program (WAUFP) were 76 (106 for 2022), a decrease of 28%. In addition, 28 (26) students enrolled in the mid-year entry WAUFP. Out of those enrolments 73 (96) students completed the full year program and 22 (17) completed the mid-year version.

2024-25

The 2024-25 applications cycle saw 14,883 applications made through TISC (13,988 in 2023-24). This reflects a 7% increase in applications compared to the previous year.

The issuing of early offers to applicants either directly by universities, or via TISC continued in 2024-25 and commenced from the beginning of September 2024 as per the Federal Minister of Education's recommendation. As almost all early offers in this year were through TISC we can report that 7,571 Year 12 applicants (61% of total Year 12 applicants) received an early offer via TISC. Of these 84% received the same main round and/or second round offer as their early offer, and 98% received a final offer of some kind.

The universities made offers to 13,272 TISC applicants in total (12,217) in 2023-24. Offers were made to 12,053 (11,016) WA Year 12 students, or 97% (94%) of all WA Year 12 applicants. The total number of offers made increased by 8.6%. It is noted the percentage of offers made to WA Year 12 applicants increased by 1% to 97% in 2024-25. This is the highest percentage recorded in the past 17 years.

The Educational Access Scheme continued to facilitate applicants to have disadvantage considered as part of their application for university study. Some 1018 (902) students requested consideration through this scheme and 800 (628) offers were made to students who applied for the EAS, although these applicants may have received an offer irrespective of their EAS application.

The Special Tertiary Admissions Test (STAT) accommodated 714 candidates in the 2024 STAT year (1,070 in 2023). In 2024, 90.1% (87.8%) of candidates who sat both components of the STAT met the minimum entry requirements for Curtin, ECU, Murdoch, and UNDA. (Note: For 2025 admission, UWA did not set minimum STAT scores but required the scores for STAT WE and at least one component of STAT MC to equate to a notional ATAR equal to or greater than the minimum required for the course.)

Enrolments in the WA Universities' Foundation Program (WAUFP) were 93 (76 for 2023), an increase of 22%. In addition, 25 (28) students enrolled in the mid-year entry WAUFP. Out of those enrolments 76 (73) students completed the full year program and 23 (22) are due to complete the mid-year version in June.

Information Technology Developments

TISC IT has been pivotal in maintaining essential infrastructure and supporting the annual admissions process. Over the past year, several strategic projects have been initiated to upgrade core IT infrastructure, integrate hybrid cloud solutions, improve cybersecurity, and enhance the admissions process and application assessment.

Key Achievements

- **Application System Enhancements:** Significant upgrades to the xQTISC system, including new STAT booking components and WAUFP enrolment maintenance.
- **Early Offer Rounds:** Successful UWA and Curtin University onboarding for early offer processing through TISC.
- **Predicted ATARs:** Implementation of predicted appraisal parameters to assist in early offer assessments.
- **Data Submissions:** Efficient API-based solutions for data validation and submission to the Department of Education.
- **USI Validation:** Improved data quality through API-based USI validation with the Government portal.
- **Mid-year Results:** Direct release of Mid-year results and UAALs to students via TISCOnline.
- **Course Code Simplification:** Streamlined course codes for Experience Based entries to reduce administrative efforts.
- **Literacy eligibility support:** calculating literacy based on the completion of WA and Interstate Year 12 studies, and updates to many other literacy eligibility factors.
- Skills for Tertiary Admission Test: Enhancing the database and related processes to support and process multiple STAT test sittings by a candidate within the same calendar year.

Infrastructure and Cloud Services

- **Network Security:** Replacement of end-of-life security appliances with enhanced protection capabilities.
- **VOIP Migration:** Transition to a hosted Cloud service provider, reducing failure points and costs.
- **Server Upgrades:** Completion of Windows server upgrades to maintain software compatibility and security.
- **File Server Upgrade:** Implementation of a hybrid solution with real-time Azure Cloud sync for data redundancy.
- **Oracle Cloud Integration:** Significant progress in replicating the on-premises Oracle environment to Oracle Infrastructure Cloud.
- **Hyper-Converged Infrastructure:** Deployment of Dell HCl, supporting over 30 virtual servers and enhancing operational reliability.
- **Database and Application Migration:** Transition of Oracle and SQL Server databases to high-availability configurations on new infrastructure.

Future Directions

- Continued enhancement of TISC systems to support admissions and business processes.
- Further integration of cloud solutions to ensure high service availability and data protection.
- Ongoing improvements in cybersecurity measures and infrastructure resilience.

TISCONLINE STATISTICS – 2023/2024

These statistics pertain to the TISC public website (www.tisc.edu.au) from July 1, 2023, to June 30, 2024. Over 344,000 unique visitors accessed the TISC website during this period, registering approximately 13 million views of content pages.

The busiest period was December, due to the release of Year 12 results and the main round, accounting for around 16% of the overall traffic.

The three primary services most utilised were the Course Search and course-related content, the ATAR Calculator and ATAR-related resources, and information related to requirements and preparation for online application.

The graph below illustrates the overall monthly activity, expressed as a percentage of unique visitors and page views on content pages.



University Admissions Applications

Applications for the 2024 university entry opened on May 1, 2023, with 13,987 applications (11,525 from Western Australian Year 12 students and 2,462 from other sources) received for the cycle.

97.9% of preference changes were received online, and TISC adjusted the remaining 2.1% to address course discontinuations, withdrawals and late corrections.

The graph below displays daily activity for the number of applications submitted and changes of preferences committed online. The change of preferences shows increased activity in December following the release of WA Year 12 results and continued until after the release of main round offers.



Release of Results and Offers

The Western Australian Year 12 results for 12,961 students, with at least one scaled score, were released on 16 December 2023. Of these students, 86% viewed their results online.

The main round offers for the 2024 semester one university entry were released on 21 December 2023, and the second round on 18 January 2024. Over 49% (7,725) of applicants with main round offers and over 76% (2,064) of applicants with second round offers viewed their offers online.

The WAUFP Standard results were released on 1 December 2023, with 82% of candidates viewing their results online.

Web Traffic Source

The primary online traffic source is direct visits to the site, which have exceeded 2 million this year. Referral traffic accounts for only a small portion of the overall traffic; the graph below shows referral traffic from member universities over the years.



TISCONLINE STATISTICS – 2024/2025

These statistics pertain to the TISC public website (www.tisc.edu.au) from July 1, 2024, to December 31, 2024. Over 241,000 unique visitors accessed the TISC website during this period, registering approximately 10.8 million views of content pages.

The busiest period was December, due to the release of Year 12 results and the main round, accounting for around 22% of the overall traffic.

The three primary services most utilised, in order of usage, were Course Search and courserelated information, ATAR Calculator and ATAR-related information, and Information about requirements and preparation for online application.

The graph below illustrates the overall monthly activity, expressed as a percentage of unique visitors and page views on content pages.



University Admissions Applications

Applications for the 2025 semester one university entry opened on 1 May 2024, with 14,743 applications (12,341 from Western Australian Year 12 students and 2,402 from other sources) received for the cycle.

97.9% of the preference changes were received online, and TISC adjusted 2.1% to address course discontinuations, withdrawals and late corrections.

The graph below displays daily activity for the number of applications submitted and changes of preferences committed online. The change of preferences shows increased activity in December following the release of WA Year 12 results and continued until after the release of main round offers.



Results Online

The Western Australian Year 12 results for 13,334 students, with at least one scaled score, were released on 14 December 2024. Of these students, 87% viewed their results online.

The main round offers for the 2025 semester one university entry were released on 20 December 2024, and the second round on 20 January 2025. Over 50% (5,265) of applicants with main round offers and over 77% (2,189) of applicants with second round offers viewed their offers online.

The WAUFP Standard results were released on 29 November 2024, with 74% of candidates viewing their results online.

Web Traffic Source

The primary online traffic source is direct visits to the site, which have exceeded 2.8 million this year. Referral traffic accounts for only a small portion of the overall traffic; the graph below shows referral traffic from member universities over the years.



LIAISON

School Curriculum and Standards Authority Liaison

Thanks to ongoing co-operation between TISC and SCSA, and the dedicated work of staff at both organisations, Year 12 results and ATARs were again released before Christmas in 2023 and 2024. The release of results and ATARs was completed smoothly on the nominated date.

TISC and SCSA continue to work closely on issues of common interest, with strong cooperation between the two bodies to achieve the best results for WA students. The TISC CEO and Board Chair have met with SCSA leadership on a number of occasions through the year and liaised on issues such as Year 12 course incentives, the WACE refresh and the State Government pathways to post-school success review.

National Liaison

National Data Collection of Applications and Offers

TISC again participated in the Federal Government's national data collection of applications and offers for undergraduate university places for which applications are made through Tertiary Admission Centres (TACs). Data was transferred to the federal Department of Education via its TCSI infrastructure.

Australasian Conference of Tertiary Admission Centres (ACTAC)

Staff from each of the states' Tertiary Admission Centres meet throughout the year to discuss common challenges and issues. TISC's CEO and senior management attended a number of inperson and virtual meetings with ACTAC colleagues to share best practice and improve collaboration between TACs. Key engagement in 2024-25 included the Universities Accord recommendations, on-going work to refine recognition of achievement in the International Baccalaureate, launching a new ACTAC website, and exploring further collaboration and benchmarking activities across TACs.

APPLICATIONS PROCESSING 2023/24

The rapidly-changing admissions environment over the past few years means these statistics, and in particular any trends, should be interpreted with caution. The following factors, among others, may have influenced the statistics:

- COVID-19 including border restrictions and special considerations
- Early offer schemes
- Application fee changes
- Changes in application opening dates and offer round dates

The number of WA Year 12 applicants increased again, which is pleasing to see. Non-WA Year 12 applicant numbers continue to decline, following a long-term trend that is common to all Tertiary Admissions Centres across Australia.

Communication with Applicants

The main method of communication with applicants is by email. Logs of emails sent are not kept, but sending and answering emails constitutes a high proportion of the workload for applications staff. Types of emails sent include:

- Bulk emails manually sent by TISC staff to request extra submissions or advise of extra requirements within three working days of an application/preference being inserted.
- Bulk emails to applicants who meet certain specified criteria, including ad hoc at the requests of universities.
- Emails sent manually by TISC staff to follow up on incomplete or missing documents.
- Replies to applicant queries.

Text messaging (SMS) is also used where email addresses are invalid, or communication is urgent. 92 text messages were sent between May 2023 and January 2024.

Other forms of communication with applicants in 2023 included:

- School visits
- Webinars
- Social media (Facebook and Instagram).

Timing of Applications

Almost half of all applicants this year (49%) applied by the end of July, showing a significant shift in applicant behaviour since the removal of the tiered fee system and the shift to an earlier opening date. A small number of high-demand courses close on 30 September, and one on 30 November, however we can see this now has limited impact on overall applications by month.

Withdrawn Applications

Duplicate applications (mainly WACE students who apply incorrectly) and Curtin re-enrollers are down significantly from the previous year. The increase in school visit presentations and emphasis on application procedures may have contributed to the former, whilst the

latter is probably attributable to Curtin encouraging non-Year 12 applicants to apply directly to the institution.

Preferences

How many preferences did TISC applicants list?

The chart to the right shows the percentage of applicants who listed 1, 2, 3, 4, 5, or the maximum 6 preferences. WA Year 12s were more likely to list 6 preferences (36.8%) compared to other applicants (16%).

Data is taken at the end point of the application; applicants may have changed, added or removed preferences during the cycle. In total, 6728 applicants changed preferences a total of 15,371 times, with the median number of preference changes being two, showing most applicants do benefit from the flexibility of changing preferences throughout the cycle.

Early Offers to Year 12 Applicants

Following the widespread adoption of early offers to Year 12s as part of responses to the COVID-19 pandemic, the five universities again each offered some sort of scheme for Early Offers to WA Year 12 students. Many of these offers were made outside the TISC system, so limited information is available at this time.

Preliminary Offers to Type 3 Applicants

Universities were able to make on-demand offers through the TISC system in selected courses to qualified non-Year 12 applicants, for first preferences only. Only 57 preliminary offers were made in this cycle, most likely because most non-Year 12 applicants apply directly to the universities, or if they are applying through TISC it is for quota courses where Preliminary offers are not made.

Entry Pathways

Enabling Programs completed in Year 12

In 2023, 1145 WA Year 12 applicants (668 in 2022), who applied for university through TISC, completed or had intended to complete a university enabling program as part of their Year 12 studies:

- 701 enrolled in Curtin's UniReady in Schools program (508 in 2022)
- 160 enrolled in ECU's UniPrep Schools program (97 in 2022)
- 280 enrolled in Murdoch's FlexiTrack High or TLC Learning for Tomorrow program (63 in 2022, however in 2022 these students could have applied directly to Murdoch)
- 4 enrolled in Notre Dame's new UniPath program.

TISC relies on applicants self-declaring these enrolments.

Applications and Offers for Enabling Programs

In total, 2120 applicants listed at least one enabling program as a preference (2327 in 2022/23). Only 31 applicants who listed at least one enabling program as a preference received no offer, demonstrating the wisdom of listing at least one as a back-up preference. The table below indicates the number of applicants and the number of offers made for each enabling program; most applicants who did not receive an offer in an enabling program as per this table, received an offer in a higher preference – that is, they did not need to use their back-up.

Adjustment Factors

Each university considers adjustment factors which can increase a WACE student's ATAR to a Selection Rank for that university, based on a number of factors including school attended and

ATSI status. Some of these factors are programmed by TISC, and a summary of these appears in the table below. No significant change is noted in these numbers from last year. The University of Notre Dame Australia applies adjustment factors on an individual basis.

Portfolio and Experience Based Entry Pathways

Curtin's Portfolio Entry Pathway was available for a selection of Curtin's courses. There were 112 offers made to applicants eligible for the Portfolio Entry Pathway (103 to WACE applicants), slightly down from last year.

ECU, Murdoch and UWA all offer various portfolio and/or experience-based entry pathways, however these don't use separate TISC codes, so separate statistics are not available via the TISC system for these. This year, for the first time, Portfolio documents could be submitted through TISC, with their own category.

Educational Access Scheme

TISC managed a common scheme to address applicant disadvantage, the Educational Access Scheme. To be considered applicants had to select at least one EAS category and upload supporting documentation to a confidential area of their application. This year, TISC conducted assessment of EAS applications as a pilot project, which was taken up by Curtin, ECU and Murdoch. Further information and analysis of that pilot will take place shortly.

A total of 902 TISC applicants requested to be considered for the EAS. Of these, 601 submitted at least one supporting document (of 751 applicants 506 submitted at least one document in 2022), and 426 were marked as complete by TISC (284 in 2022). In total 3,064 EAS documents were submitted – 2,284 uploaded by applicants and 176 uploaded by TISC.

A total of 628 offers were made to EAS applicants, however this does not necessarily mean the offers were made on the basis of their EAS application.

We continue to see a decline in non-Year 12 applicants. Most of these applicants can apply directly to the university of their choice free of charge. Year 12 applicants increased quite significantly, leading to an overall increase in applications of 6.4 per cent. Notably, this is the highest number of WA Year 12 applications TISC has processed since 2017.

Only 567 applications were inserted on 1 October (applications made on 30 September, the deadline for Medicine courses), which is traditionally a peak. It is possible that 31 August became a "de facto" on-time closing date as it was the first closing date applicants heard. Other peak days

are generally Mondays which collate all applications made over the weekends, and these seem to take place approaching early offer dates. TISC does advise applicants that applying 1-2 weeks before an early offer date is advisable so that universities have time to assess the application.

Duplicate applications (mainly WACE students who apply incorrectly) increased from the previous year. The increase may be due to all portfolio and experienced based Year 12 applicants now having to apply through TISC.

1.4 Preferences



There is a relatively consistent distribution of first preferences year-on-year, with The University of Notre Dame increasing their share of overall preferences, likely driven by the addition of their Medicine assured pathway.

7686 applicants changed preference a total of 17,790 times.

•The TISC system allows applicants to easily change their mind at no cost, giving maximum flexibility.

• Preference changes are checked by TISC to ensure no additional information is required from applicants.

36 per cent of applicants used all six preferences.

• This demonstrates the benefit of a centralised admission system, that applicants can give themselves the best chance of getting an opportunity to study at university.

1.6 Documents

18,007 documents were attached to 5,588 applications. 5,307 applicants uploaded 16,739 documents. TISC staff uploaded 1,268 documents on behalf of 818 applicants.

1.7 Offers

14,225 offers – each offer representing an opportunity to study – were made through TISC for Semester 1 2025 admission. This figure includes preliminary offers, main round offers and second round offers. It does not include early offers to Year 12 students. Some applicants may be counted twice, for example if they received a main round offer, utilised the TISC Safety Net, and then received a higher second round offer.

13,272 students received an offer through TISC, an increase of approximately 8.6% on the previous year.



1.8 Long term trends

Deep troughs are represented by the half-year cohort (2015) and the 2021 year where Year 12 applicants were able to apply directly to the universities. Otherwise, applications followed a general

upward trend until around 2011, followed by a general downward trend. Peaks are often attributable to external economic circumstances such as high unemployment.



For 2025 admission, 96.6% of WA Year 12 applicants received an offer, a number which has followed a gradual upward trend since 2022. The percentage for other applicants is quite low, largely because a significant percentage of other applicants are applying for highly competitive courses such as Medicine, that make very limited numbers of offers.

1.9 Early Offers

This year, almost all early offers were made utilising the TISC system (with the exception of Notre Dame's Young Achievers Early Offer Scheme), which has allowed us to gather some data on these for the first time.

7571 (61%) of Year 12 applicants received an early offer via TISC. Of these, 84% received the same final offer* as their early offer, and 98% received **some** final offer.

8680 WA Year 12 applicants received an ATAR

This represents 72.0% of WA Year 12 applicants.

8500 (97.9%) of these received an offer. The offer may have considered other factors in addition to the ATAR.

1533 WA Year 12 applicants applied using a Certificate IV or Diploma qualification

1438 (93.8%) of these received an offer.

1563 WA Year 12 applicants applied using previous university study

1468 (93.9%) of these received an offer.

SPECIAL TERTIARY ADMISSIONS TEST 2023/24

The Special Tertiary Admissions Test (STAT) is an aptitude test designed to assess a range of competencies considered important for success in tertiary study. Many tertiary institutions in Australia use STAT as part of their admissions procedures for mature-age applicants.

The Australian Tertiary Admissions Centres (TACs) were party to the development and implementation of the STAT program. However, the intellectual property of all forms of the STAT is owned by the Australian Council for Educational Research (ACER). Western Australia is the only state that currently administers the STAT in-person via TISC.

The STAT consists of two tests: a Multiple-Choice test (STAT MC) and a Written English test (STAT WE). STAT MC is a two-hour test containing 70 questions, half of which have a verbal emphasis (social science/humanities) while the other half have a quantitative emphasis (mathematical/science). STAT WE is a one-hour written English test, consisting of two short essay questions. Part A is a public affairs issue that invites argument, while Part B asks candidates to write from a more personal point of view. Each section gives a choice of four topics.

Both tests are produced and marked by ACER in Victoria. Every two years, half the multiple-choice items are replaced with new items and the other half of the items are carried over from the previous test cycle to ensure comparability across years.

ACER send results files electronically to TISC after each STAT sitting, including online and overseas sessions, for uploading to the national database. The STAT National Database was established in November 1996. It was developed and is administered by TISC. It contains results for all candidates who have sat STAT in Australia from 1996 onwards.

STAT Enrolments

In the 2023 STAT year 1070 candidates attended STAT (this includes 515 school leaver candidates who sat in November, January, and February). The following table shows the breakdown of enrolments in each test as well as a comparison with previous years:

Testing sessions in the metropolitan area

There were ten metropolitan sessions run throughout the year at Canning College in Bentley. The dates for these are shown below:

We offer two special sessions held on a Friday at TISC for people who, for work or religious reasons, cannot sit STAT on a Saturday. A special Friday session was held on 12 May and 17 November. There was one candidate for each session.

Due to the days the public holidays fell over the Christmas/New Year period, a mid-week testing session was again held on Wednesday 3 January.

Sessions were also organised for 28 candidates with special needs. These sessions were held in the TISC office.

No additional charge was raised by TISC for organising and running the sessions for these candidates.

Scheduled testing sessions in regional areas

Tests in regional areas are held twice a year – in May and November. The dates are advertised every year on the STAT booking form and the TISC website. Venues and supervisors are organised by the STAT Coordinator.

In May 2023, 6 sessions were held in 6 regional centres, and in November 2023, 5 sessions were held in 5 centres, including 3 of the centres where a session was held in May 2023.

There were more country STAT sessions held than in the previous year. There were 25 candidates who enrolled to sit the STAT in regional areas in 2023 compared to 24 in 2022. Enrolments for the 2023 country testing sessions were as follows:

Scheduled testing sessions in prisons

TISC has a very flexible policy for scheduling testing sessions in prisons as the prisons have Education Officers available to supervise the candidates. Contact is made with the Education Officers each year and sessions can be held on a weekday between May and November each year. There were no sessions held in prisons this STAT year.

Special use of STAT

Many of the candidates sitting the 3 and 6 January 2024 sessions were Year 12 English ATAR courses students' who had achieved a competitive ATAR or had completed a Certificate IV but had not met competence in English.

A few Year 12 English General course students, who had completed a Certificate IV, were also invited to the sit STAT WE only in order to meet the university English competency requirement. These students were allowed to sit the STAT from late November onwards, after the completion of the WACE examinations.

The University of Western Australia requires Year 12 students to take both STAT WE and STAT MC test and to achieve a mark of 140 or better in both STAT WE and STAT MC (Verbal component). The other four universities require Year 12 students to sit STAT WE only and to achieve a mark of 140 or better in this test.

Over the last four years UWA have also allowed (with written permission) Year 12 students who did not achieve a high enough ATAR or had no ATAR to sit the STAT for admission purposes. UWA did not set required minimum STAT scores but required the scores for STAT WE and at least one component of STAT MC to equate to a notional ATAR equal to or greater than the minimum required for the course. Year 12 students using this pathway for admission purposes were allowed to sit the STAT after the completion of the WACE examinations.

There were 515 Year 12 students sitting the STAT, of whom 329 sat STAT WE only. The number of students sitting STAT WE only, decreased by 5.5% (compared to the 348 who sat in 2022).

The number of students sitting both sections of the STAT decreased from 219 to 186, a decrease of 15.1%.

89.4% of those who used STAT WE only to meet literacy, met this requirement. 65.1% of those using both STAT MC and STAT WE met competence in English for UWA.

SPECIAL TERTIARY ADMISSIONS TEST 2024/25

The Skills for Tertiary Admissions Test (STAT), previously known as the Special Tertiary Admissions Test, is an aptitude test designed to assess a range of competencies considered important for success in tertiary study. Many tertiary institutions in Australia use STAT as part of their admissions procedures for mature-age applicants.

The intellectual property of all forms of the STAT test is owned by the Australian Council for Educational Research (ACER) and Western Australia is the only Australian state that currently administers the STAT in-person via TISC.

The STAT consists of two tests: a Multiple-Choice test (STAT MC) and a Written English test (STAT WE). STAT MC is a two-hour test containing 70 questions, half of which have a verbal emphasis (social science/humanities) while the other half have a quantitative emphasis (mathematical/science). STAT WE is a one-hour written English test, consisting of two short essay questions.

Both tests are produced and marked by ACER in Victoria. Every two years, half the multiple-choice items are replaced with new items and the other half of the items are carried over from the previous test cycle to ensure comparability across years.

ACER send results files electronically to TISC after each STAT sitting, including online and overseas sessions, for uploading to the national database. The STAT National Database was established in November 1996. It was developed and is administered by TISC. It contains results for all candidates who have sat STAT in Australia from 1996 onwards.

STAT Enrolments

In the 2024 STAT year 714 candidates attended STAT (this includes 122 school leaver candidates who sat in November, January, and February).

The public holidays around Christmas and New Year meant that our end-of-year sessions were held one week apart on Saturday 28 December 2024 and 4 January 2025.

Sessions were also organised for 12 individual candidates with special needs. These sessions were held in the TISC office. No additional charge was raised by TISC for organising and running the sessions for these candidates.

Scheduled testing sessions in regional areas

Tests in regional areas are held twice a year – in May and November. The dates are advertised every year on the STAT booking form and the TISC website. Venues and supervisors are organised by the STAT Coordinator.

In May 2024, STAT sessions were held in Albany, Bunbury and Narrogin. In November 2024, STAT sessions were held in Albany, Bunbury, Kalgoorlie and Merredin.

Scheduled testing sessions in prisons

Over the last four years UWA have also allowed (with written permission) Year 12 students who did not achieve a high enough ATAR or had no ATAR to sit the STAT for admission purposes. UWA did not set required minimum STAT scores but required the scores for STAT WE and at least one component of STAT MC to equate to a notional ATAR equal to or greater than the minimum required for the course. Year 12 students using this pathway for admission purposes were allowed to sit the STAT after the completion of the WACE examinations.

There were 232 Year 12 students sitting the STAT, of whom 110 sat STAT WE only. The number of students sitting STAT WE only, decreased by 66.5% (compared to the 329 who sat in 2023). This significant reduction in Year 12 candidates booking to sit only the Written English test is likely due to changes to Curtin University's English language requirements, which broadened how Year 12 applicants could meet their English language requirements.

The number of students sitting both sections of the STAT decreased from 186 to 122, a decrease of 34.4%, which is likely due to a combination of declining STAT bookings and The University of Western Australia's experience-based entry options.

91.81% of those who used STAT WE only to meet literacy, met this requirement. 77.9% of those using both STAT MC and STAT WE met competence in English for UWA.

Setters, Checker and Markers

a) Standard

Twelve subject examination papers were written for the Standard examinations in 2023. All subjects, except ELACS, used the School Curriculum and Standards Authority WACE ATAR Year 12 syllabi. Most Setters and Checkers were experienced in WAUFP examination setting; there were 3 new Setters and 1 new Checker for the 2023 papers. All papers were marked independently by 2 experienced markers. Marking was completed electronically via EServices and the processes ran smoothly for all subjects.

b) Mid-Year

Eight subject examination papers were set for Mid-Year WAUFP examinations. Most Setters are appointed based on recommendations from Provider Colleges. Most of the Checkers currently come from within the Provider Colleges (including retired teachers) and some are appointed based on recommendations from Provider College staff.

Final Examinations

An examination timetable was prepared by TISC and distributed to the colleges at the beginning of August. The final examinations were held over 2 weeks and coincided with the WACE examinations. TISC organised the supervision of the external examinations. The Chief Supervisors attended a training meeting at TISC the week before the commencement of the examinations. At this meeting all examination procedures were reviewed. All supervisors were sent a Supervisor's Manual outlining how to run the examinations and all signed a Supervisor's Agreement that outlined their duties. TISC ensured that all supervisors held a current Working with Children Check card.

Subject Moderation

Moderation of each college's assessments was carried out by standardising them to the same mean and standard deviation as the exam results of each college.

Scaling

a) WAUFP

The Scaling Process took place at TISC on 29 November 2023. The Scaling Report was circulated for the Members Advisory Committee meeting on 8 December 2023.

b) Mid-Year WAUFP

The Scaling Process took place at TISC on 10 June 2024.

a) Standard

Thirteen subject examination papers were written for the Standard examinations in 2024. All subjects, except ELACS, used the School Curriculum and Standards Authority WACE ATAR Year 12 syllabi. Most Setters and Checkers were experienced in WAUFP examination setting; there were 2 new Setters and 2 new Checkers for the 2024 papers. All papers were double-marked independently by experienced markers. Marking was completed electronically via EServices and the processes ran smoothly for all subjects.

b) Mid-Year

Eight subject examination papers are being set for Mid-Year WAUFP examinations. Most Setters are appointed based on recommendations from Provider Colleges. Most of the Checkers currently come from within the Provider Colleges (including retired teachers) and some are appointed based on recommendations from Provider College staff.

Final Examinations

An examination timetable was prepared by TISC and distributed to the colleges at the beginning of August. The final examinations were held over 2 weeks and coincided with the WACE examinations. TISC organised the supervision of the external examinations. The Chief Supervisors attended a training meeting at TISC the week before the commencement of the examinations. At this meeting all examination procedures were reviewed. All supervisors were sent a Supervisor's Manual outlining how to run the examinations and all signed a Supervisor's Agreement that outlined their duties. TISC ensured that all supervisors held a current Working with Children Check card.

Subject Moderation

Moderation of each college's assessments was carried out by standardising them to the same mean and standard deviation as the exam results of each college.

Scaling

The Scaling Process took place at TISC on 22 November 2024. The Scaling Report was circulated for the Members Advisory Committee meeting on 13 December 2024.

Results

On 29 November all WAUFP results were made available on the TISC website. Results letters and certificates were also posted. TISC uploaded results for the International Centre of each university and also for the Provider Colleges.

Certificates of Achievement and Letters of Congratulations

Certificates of Achievement were awarded to 75% of Standard WAUFP students. Students received a certificate if they:

- Scored 50 or higher in the subject ELACS and therefore achieved English language competency, and
- Obtained a Combined Percentage Score (CPS) of at least 50.

Letters of congratulations were sent to students who had a CPS in the top 5%, and the top student in each subject with enrolments of 10 or more students. **Future Changes**
